I am still waiting for the OFFICIAL POLICE REPORT AS PROMISED. This is also requested for legal action. Yesterday's incident with administration (after I checked in for advising) at South Puget Sound Community College - they are barring and banning me from ever attending again due to their prejudices. (They are keeping all my money + emails + transcripts.)

Clear and concise statement of facts upon which complaint is based (including times, dates, places and individuals involved):

Wednesday Feb 23, 2022 12:04PM I called 9-1-1 from 360-878-3244 at South Puget Sound Community College 360-596-5200 2011 Mottman Road SW, Olympia, WA 98512 as I was there for advising and planning - finished scholarship (financials) for about 30 mins. Security Director Fred Creek 360-596-5402 pulled me aside from advising and got Vice president for Student Services Dave Pelkey involved in a private meeting room One Stop Desk - Building 22 Second Floor, Olympia Campus. They escalated and lied about not wanting to see me or have me as a student. They refused to acknowledge me or their wrong doing with working with BLM on campus and Dave claimed "I don't care about lawsuits." I walked out of the meeting room and rose my voice for everyone to hear my disapproval of their black power horseshit (over a dozen witnesses with multiple employees), including a man with a therapy/working dog. They are barring me from attending classes and will keep all my money. They refuse to UNLOCK my accounts and will not allow me to get email or transcripts. DISPATCH TOLD ME TO WAIT OUTSIDE THEN OFF CAMPUS TO AVOID FURTHER

ESCALATION OR INTERACTIONS WITH THEM!

Fred Creek and another security officer whom approached from around the outside of another building stated that they had to "Escort You To Your Vehicle." (before entering my car, Fred Creek stated "I HOPE YOU GET HELP" ... As they pointed at either a camera or read my plates once they saw me in my car / started the engine in the parking lot.) Just like they did with their orchestrated graffiti stunts and blaming whitey!!!!

-- Officer Jefferson Davis of Olympia Police Department called back Feb 23, 2022 12:25PM -- I explained to Officer Davis how the school treats law abiding citizens and is violating laws but they claim I am in THEIR VIOLATION and it is THEIR SCHOOL -- I HAVE BEEN SERVED NOTICE and if I ever return I will be arrested! Officer Davis explained this to me also and I told him they told me to use the name "Jon Presley" --- security is suppose to followup with Director of Disability, John Rajcich about code "Croatia". As Fred Creek says he knows him personally and agreed to do so.

I obtained for the first time a printout stating they wanted to hold this secret meeting but wasn't ready for their verbal / psychological assaults. "HOW DOES THAT MAKE YOU FEEL?" -- They claimed I wasn't allowed to appeal and there is no one else that will help as Dave Pelkey claims "I am it" ... and confirmed " I blocked your account." ... "Go ahead, call the police." -- Officer Jefferson Davis as in DIXIE asked for my full name, PATRICK A TURNER and DOB 10/19/85 to go with my phone number that will be on the official POLICE REPORT!

What, if any, efforts have been made to resolve the issue prior to submitting this complaint?

I've been a student, got my accepted letter in the mail for the current year and appealed financial - I went in to pay for my 5 credits of classes as stated in appeals letter from 2/11/2022. If they had a problem with my beliefs or people, then that is their own fault. The school admins and security are very bias against Europeans especially if they are proud of who they are.

Please include a statement of requested remedy or corrective action:

I WOULD LIKE TO PRESS CRIMINAL CHARGES AND SUE THE SCHOOL ; SUE INDIVIDUAL PARTIES INVOLVED ; REMOVE THEIR POWER AND FINANCING (they are overstepping & should not be allowed to steal) / SPSCC admin hording FinAid scholarship money.

A slap on the wrist or just a hand shake would have been nice to carry on the day, like we are watching you "oh, we can't we will catch COVID-19" and they could have said "when the Communist, Niggas and the Jews are poking fun at you, don't respond, just walk away." - Don't engage the enemy and stop giving away your position.

There was no negotiation, no prior written notices or no appeals involved -- first offense (claimed I have no rights and as stated by Dave Pelkey that he is to blame for it all - it was his final decision, although required to have director of security involved) -- Pierre Trudeau and Malcolm X are just doing as they please with their Black Panthers Communist Party to bring down whitey while they have security orchestrate graffiti / riots like The Evergreen State College to get more press or money from others.
