Claimed I need to check in for a Scholarship & Mental Health Services

Basis of Complaint- Please state nature of alleged violation(s), including policy, rule or law violated:

Friday, Feb 25, 2022 2:38PM a call from 360-754-1338 from someone named Amanda left a voicemail from an Olympic Health and Recovery Mobile Crisis Team. I returned the phone call at 3:18PM from my cell phone 360-878-3244 and spoke with a Neisom who explained to me that they are a state agency for Thurston - Mason County. The referral came directly from someone dealing with WA State Scholarship Program. I advised I'm interested in the grant and school programs still. He insisted that I needed to check in as urgent referral and asked if I have thoughts of suicide or hurting other people? I told him NO and asked if he did, his response was that sometimes he did. I told him of the CRISIS CLINIC HOTLINE as they can help or the counselors at school. I told him to add me to their "DO NOT CALL LIST" and to place a "FRAUD" alert out because if they claim they aren't scholarship programs. I did not make the call and I didn't give permission for anyone to use my name or number to reference me for health services. I'm a business student and take gym classes. We discussed about keto and paleo diets but no need of health services. I advised him that is harassment in reference to 02/23/2022 incident at SPSCC.

Clear and concise statement of facts upon which complaint is based (including times, dates, places and individuals involved):

Friday, Feb. 25, 2022 3:30PM I called the WA STATE SCHOLARSHIP PROGRAM at 1-877-899-5002 and advised them of FRAUD as Olympic Health and Recovery (a state agency) is claiming that they are getting referrals for their scholarship program. I am still interested and already applied for this school year with S.P.S.C.C. but these unknown people shouldn't be using their name - add to a do not call list. I also advised

of incident with Vice President Dave Pelkey in that I want to press charges with anti-harassment orders for almost laying hands on me 02/23/2022.

What, if any, efforts have been made to resolve the issue prior to submitting this complaint?

Friday, Feb. 25, 2022 4:10PM I called S.P.S.C.C. Financial Aid 360-596-5241 with a woman who answered and she claimed she couldn't help with scholarship fraud. I must talk to security. I advised her of director of Security Fred Creek and V.P. Student Services Dave Pelkey, she agreed. I provided her with my name and number. Patrick Turner 360.878.3244

Please include a statement of requested remedy or corrective action:

Figure out why FinAid says it was security F. Creek who was at fault and also agreed that D. Pelkey can only remedy fraud or referrals for "scholarships" to Olympic Health & Recovery. This is a retaliation move by staff and confirmed by multiple parties yet again.

I want to press charges against F. Creek and D. Pelkey. I need to protect my family and would like restraining / Anti-harassment orders against both of them. I would like to sue the school for damages and would like my accounts unlocked. I should be allowed to take classes and/or transfer credits as needed.
