Offense

On 03/27/19 while working as the swing shift patrol Sergeant, I was advised by Det. Sgt. Herbig that the FBI was working a case on a Patrick Turner who was claiming to be involved in white supremacy groups and was making threats towards staff members at The Society Bar located at 111 Washington ST SE.

I was familiar with an earlier OPD report (Case #19- 1461) where a bartender at Society, Zak Burgess, reported an escalation in Patrick's behavior and I had reviewed some Facebook posting where it appeared that Patrick was posting Nazi propaganda posters and other White Supremacy type information. At the time there were not specific threats but Zak was concerned because Patrick was in the bar all the time and the bar has several black employees.

Today, Sgt. Herbig made me aware of recent posting where Patrick was talking about Viking pride and going to Valhalla. He also showed me some recent postings of handguns and swords which seemed to be an escalation from the postings in the prior report.

One alarming photo was of what appears to be Jewish males, one of them with a rifle, with the Star of David in the middle and what appears to be the Society's front entrance and sign blended into the background. I have attached the photo in RMS.

I contacted Zak at the Society and their staff was extremely fearful that Patrick might come and shoot up the bar.

Zak informed me that employees had been getting private messages from Patrick. One, where he created a list of name of employees and their girlfriends. One of those girlfriends goes by the nickname "Fox," and I was told that, "Fox is Dead, Long Live the Queen," was tagged on the back of the building and was also in several of the Facebook posts. Zak told me Patrick had been infatuated with Fox and was frustrated that Fox didn't like him.

I contacted FBI Special Agent Douglas Capra who stated the FBI was concerned by Patrick's behavior and they requested that he be detained if we contacted him. I also reviewed the information and believed that he needed to be detained to insure that he didn't hurt anyone and be evaluated by a mental health professional.

At 2145hr there was a 911 call from the Society that Patrick was standing at the front entrance looking in the windows.

Officer Henrichsen and I contacted Patrick and detained him in handcuffs. We did not locate any weapons and agreed to come to OPD to speak with the FBI.

Agent Capra came to OPD and interviewed Patrick. After the interview we decided to have Patrick evaluated by the DCR. Shelly Barnett came to OPD and reviewed the Facebook postings, Facebook messages and interviewed Patrick. Shelly decided to detain Patrick to St. Peters Hospital.

Officer Edwards transported Patrick to St. Peters Hospital.

I have attached the DCR Custody Authorization paperwork in RMS.






