REASON FOR REFERRAL: Sergeant Houser reports that Patrick has been trespassing at a bar and "posting neo-nazi and anti-black statements on Facebook." He reports Patrick presents as delusional and admits to not taking psychiatric medication. They are holding him at police station, and he has not been charged with anything. He has been interviewed by FBI and did not make any explicit threats.

The Respondent was referred for an involuntary treatment act assessment by Sgt. Howzer with Olympia Police Department on 3/26/19 at 11:21PM due to his concerns for grave disability and danger to others as the Respondent has been trespassing at a local bar and has been posting neo-nazi and anti-black statements on Facebook.

Based on my personal observation and investigation of specific facts alleged, and information obtained from reliable witnesses the facts that led me to conclude that the Respondent suffers from a mental disorder or a substance use disorder are as follows:

This writer arrived at Olympia Police Department on 3/26/19 at 11:41PM, and consulted with officer Howzer and FBI agent Dug Capra who reports, "The FBI got a report from the club 'Society' that the Respondent has drastically changed his appearance and demeanor in the past 3 weeks (shaved his head, starting wearing nazi looking apparel and posting neo-nazi and anti-black statements on social media and doing the z-heil salute inside the night club). He believes the bar is poisoning the water and is sex trafficking women and boys. He's made many concerning statements on social media and through text message that have gotten the attention of police and the FBI placing him as a person of interest." Agent Dug Capra informed the Respondent has been going to the club from open to close daily since October and the staff at the club know him well.

This writer introduced herself to the Respondent, described the nature of the investigation and read the Respondent his rights on 3/26/19 at 11:57PM. The Respondent appears well groomed, dressed in black slacks, a button up white shirt, black tie and black DocMartins with white shoelaces. The Respondent has fixed eye contact, blunted affect, paranoid and delusional thought process as evidenced by his reports, "Society is involved in the drug trade and sex trafficking. They've overdosed me multiple times, drugging my drinks. They wanted me to be a part of the black panther so I could get any girl I want. I'm not gonna be your Malcom X." The Respondent's FaceBook page has been filled with Nazi, Anti-Semitic, and White Power memes and posts as evidenced by hash tagging (#BePrepared #Herelcome #nomoremrniceguy #knowyourclub). The Respondent has poor insight and judgement as evidenced by text messages between the Respondent and the Society club owner regarding Fox, also known as Jaymee, the owner's girlfriend, who the Respondent claims to love and want's the club owner's blessing for her hand and heart. Fox (aka Jaymee) had to block the Respondent as she does not want to communicate with him any longer. The Respondent continued to send messages emphasizing white power and including a list of "top/high priority" individuals further stating, "FOX IS DEAD. LONG LIVE THE QUEEN!" Society club has placed a trespassing order against the Respondent to not return to the club as individuals feel they are in danger. The Respondent came in contact with Olympic Police and FBI agent Dug Capra after he trespassed on the club property on 3/26/19. The Respondent has poor insight and judgement as evidenced by the Respondent reporting, "I was overdosed with methamphetamine and MDMA they put in my drink. I've been drugged a hand full of times." This writer asked the Respondent why he kept going back after being drugged and the Respondent reports, "Because it feels good."

This writer consulted with the Respondent's father who reports a recent change in behavior as evidenced by the Respondent locking his father out of all his financial accounts that his father previously managed. The Respondent's father informs he has a history of decompensating but reports the current behavior is not something he's seen before.

The facts that led me to conclude that the Respondent presents a likelihood of serious harm and/or is gravely disabled, are as follows:

The Respondent presents as gravely disabled with a risk of serious harm due to danger to other's evidenced by the Respondent's poor insight and judgement as evidenced by his communication with 'Society's' owner regarding Fox messaging statements, "FOX IS DEAD. LONG LIVE THE QUEEN!" The Respondent is manifesting severe deterioration in routine functioning evidenced by repeated and escalating loss of cognitive and volitional control as evidenced by the Respondent entering Society night club, doing the z-heil salute resulting in him getting kicked out of the club where he then drove around the club through out the weekend playing white supremacy music and trespassed after an order was placed against him.

No alternative less than detention, including voluntary hospitalization or detoxification services, is clinically appropriate, necessary, and in the best interest of the Respondent or others because:

At this time, the Respondent is unable to participate in the development of a reasonable, available plan for safety. When asked about his willingness to accept medication management, the Respondent declined stating, 'I don't have any mental health problems, medications won't help.' The Respondent is unwilling to participate in voluntary mental health treatment as he is unwilling to take medications. The Respondent is unwilling to participate in medication management on an
