Call dad, Richard Turner 360-712-3792 12:26PM side of road told about car; agree to drive home; cannot make sister's BDAY, Kimberly Turner and Dirk Dekker family friend left voicemail 12:30PM; 360-786-5500 Thurston Co Sheriff's Office 12:35PM - OK to drive home. Alive at home 1PM talked to next door neighbor old couple about EMERGENCY. Big white truck (ext cab?), clean, looks new, sounded V8/Hemi, across street individual observing inside when called 911 1:04PM. Neighbor gave security light to use motion sensor. Truck drove off promptly after.

NOT driving due to risk of fire / death and I will not put it under car port or near flammables.
