(a club night or the week prior another incident) Saturday, February 23, 2019 estimated 9 PM I arrived at THE SOCIETY nightclub 120 4th Ave E, Olympia, WA 98501 (360) 352-1230 societyoly.com / Staff claims address is 111 Washington ST NE, Olympia, WA 98501 Personal: 360-470-3019 Business: 360-357-5812 / Koop Richard (Dj Koop) https://www.facebook.com/Koop206 was a point of contact - later on estimated about 11 PM or so (we used SNAPCHAT to communicate) - he posted a screenshot photo from the SNAPCHAT to his Facebook - location pointing to estimated Jake's on 4th 311 4th Ave E, Olympia, WA 98501 with a statement (while in the club said "go get them") - I was advised to pickup a pale skinned young couple: Joshua Wright 360-706-9260 findersfinanceinc2018@gmail.com who also claimed "club ownership" prior years ago but said "they have forget me" and Mariah a "Milla Jovovich" celebrity lookalike but everyone called her "Shadow" at the time, also known as Luckystar or GIR.

Sunday, February 24, 2019 estimated 2 AM, we walked around downtown Olympia then went to my place at 9812 Steamboat Island RD NW where they spent the night. They slept on an old mattress on the floor of my bedroom that is in storage now. (My father, Richard Turner and sister, Kimberly Turner were also at my house those days.) Music was played all night. The next day, Monday, February 25, 2019 - I dropped them off as directed and with multiple bags, mostly trash bags - I did help by providing an old backpack plus other bags to carry their items in. Afterwards I noticed somethings missing like my Anti-smoking VAPE MOD kit, laptop (should be registered with ACER under the name Heather Long bought from Walmart) and clothing / hat --possible other items from the trunk or backseat of my car 2014 Chevrolet Cruze ECO 4dr Plate lic # A0W0906 -- I'm still trying to figure out what else was STOLEN that week. I have found some clothing of theirs left in my car and home that might be used as EVIDENCE.
